

Noel Leeming x FUJIFILM NZ Film Development Giveaway Promotion

Terms and Conditions

What is this promotion?

1. This prize draw promotion ("**Promotion**") offers FUJIFILM NZ Limited ("**FUJIFILM NZ**") customers ("**FUJIFILM Customers**") who purchase a Qualifying Product (described further below) from the Retail Partner (defined below) during the Promotional Period one entry in the draw to win the prizes described in paragraph 20 (each a "**Prize**").

How long does the promotion run for?

2. The Promotion commences at 00:01 on Wednesday 26 August 2026 and continues until 23:59 on Tuesday 22 September 2026 ("**Promotional Period**"). For the avoidance of doubt, this Promotion does not apply to purchases of Qualifying Products made after 23:59 on Tuesday 22 September 2026 or to entry forms received by FUJIFILM NZ after 23:59 on Tuesday 29 September 2026.

How do I participate?

3. To participate in the Promotion, you must:
 - 3.1. purchase a product set out in paragraph 16 below from an authorised FUJIFILM NZ retail partner, Noel Leeming Limited ("**Retail Partner**") ("**Qualifying Product**") during the Promotional Period while stocks last, and keep evidence of your purchase;
 - 3.2. before 23:59 on Tuesday 29 September 2026, submit a properly and fully completed entry form at <https://www.nz.fujifilm.co.nz/promotions>. The entry form will require the following key details:
 - 3.2.1 your full name and contact details;
 - 3.2.2 your preferred delivery address;
 - 3.2.3 the date of the purchase of your Qualifying Product;
 - 3.2.4 the name of the Retail Partner that you purchased your Qualifying Product from; and
 - 3.2.5 proof of the purchase of the Qualifying Product, such as a complete and legible scan or photo of the original receipt issued for the Qualifying Product, or such other proof of the Qualifying Product as is acceptable to FUJIFILM NZ in its sole discretion.
4. Only one entry form may be completed and submitted per Qualifying Product purchased.
5. All entry forms must be validly lodged and received by FUJIFILM NZ no later than 23:59 on Tuesday 29 September 2026. FUJIFILM NZ will not process any entry forms received after this date and is not responsible for late, lost, incomplete, incorrect or misdirected entry forms.
6. FUJIFILM NZ may accept or reject any entry form in its sole and absolute discretion including, without limitation, rejecting entry forms that are incorrect, incomplete, late or otherwise not in compliance with these Terms and Conditions. FUJIFILM NZ may verify the validity of any entry form at any time and will disqualify any person who tampers with the entry process or who submits an entry form that is not in accordance with these Terms and Conditions.
7. The Promotion promotes the sale of the Qualifying Products to end users and it is not provided for the benefit of those who trade FUJIFILM NZ's products (including the Qualifying Products) in the ordinary course of their

business. FUJIFILM NZ reserves the right to decline any entry received from, or on behalf of, any such person or entity (or anyone associated with such person or entity).

8. FUJIFILM NZ may reject any entry form, and may disqualify any winner, where the Qualifying Product to which the entry form relates is returned, refunded or exchanged.
9. This Promotion is not available in conjunction with any other promotions or offers whatsoever.

How will I know if I have won a Prize?

10. Each validly submitted entry form received by FUJIFILM NZ in accordance with paragraph 3 will receive 1 entry into the draw to win a Prize.
11. The Prize draw will take place at FUJIFILM NZ's offices on Tuesday 6 October 2026. The winners will be drawn randomly from all valid entries received in accordance with paragraph 3.
12. If any successfully drawn entry form is later rejected in accordance with these Terms and Conditions, then FUJIFILM NZ reserves the right to make further draw(s) to draw a valid winner and to ensure that each Prize is won by a participant who has followed the Terms and Conditions of this Promotion.

FUJIFILM NZ will notify the winner using one of the contact details provided in the entry form and request that such winner provides to FUJIFILM NZ the necessary information to validate that winner's entry and enable delivery of the Prize (including providing details of a postal address and age). If we do not receive all required information within 5 business days of us notifying you of your win, we may reject your successfully drawn entry and carry out a subsequent Prize draw.
14. Each winner will be sent their Prize within 10 business days of being verified by FUJIFILM NZ. The Prize will be issued to that winner as a redemption code sent to the contact details on the winner's entry form.

What are the Qualifying Products?

27. FUJIFILM NZ reserves the right to accept or reject any entry form that is incorrect, incomplete or otherwise does not meet the requirements of these Terms and Conditions.
